## **Privacy Notice - Data Protection Act 1998**

We (Bishops Nympton Primary School) are a Data Controller for the purposes of the Data Protection Act. We collect personal information from you and may receive information about you from your previous school and the Learning Records Service. We hold this personal data to:

Once you are aged 13 or over, we are required by law to pass on certain information to providers of youth support services in your area. This right transfers to you on your 16<sup>th</sup> birthday. Please tell the School Administrator if you wish to opt out of this arrangement.
